For control of litter beetles (Alphitobius diaperinus, also known as darkling beetles) in their adult and immature forms (larvae and eggs) by treating livestock buildings in broiler chicken or swine production. The product is a ready-to-use liquid, intended to be sprayed in livestock buildings using a backpack sprayer. Starts to work within the first 12 hours of application. Direction for use: For best results, apply in two applications when the beetles are migrating between the floor and the walls of the facility. For the first application, apply immediately after the animals have been moved out of the building at the end of the flock. For the second application, apply after reheating of the building has begun but before introducing the new flock. To apply, spray a strip at the junction of the floor and wall, extending 1 m high on the wall and 50 cm onto the floor at a rate of 20L per 1000 m², which corresponds to 20L for 500 m² of effectively treated area. Also consider spraying a 50cm strip under the feeders. Repeat application after each flock. Make sure that the treated buildings are well ventilated and that the treated surfaces are completely dry before allowing people or animals back into the buildings. Suitable for organic farming.**
